Insurance benefits – explained in a nutshell

Trip cancellation

If the trip is cancelled or postponed due to illness, injury, medical problem, death or any other reason listed in the General terms and conditions, the costs owed under the contract will be reimbursed.

Trip interruption

If the trip is cancelled, interrupted or terminated prematurely for one of the reasons listed in the General terms and conditions, the additional costs will be covered and/or the pro rata amount of the unused, non-refundable benefits will be reimbursed.

Travel delay

If your journey is delayed by at least 3 hours, you will be reimbursed for prepaid, non-refundable trip expenses as well as a certain maximum amount for additional expenses. If you miss the start of your cruise or tour, additional transport and accommodation costs will be reimbursed so that you can start or continue your trip.

Baggage

If baggage is damaged, stolen or lost by a carrier during the trip, the cost of repair or replacement less a current value deduction will be covered.

Baggage delay

If a carrier delays the delivery of baggage during the journey, the cost of the necessary items until the baggage arrives will be reimbursed.

Medical costs abroad

If a sudden, unexpected illness, injury or medical problem occurs during the trip abroad, the reasonable and customary costs for emergency medical or dental care will be reimbursed in addition to the statutory social insurance.

Emergency medical assistance

Assumption of the costs in the event of serious illness, injury or serious medical problem for transfer to the nearest hospital, medical repatriation, a visiting trip, repatriation of relatives and/or repatriation in the event of death.

Collision Damage Waiver (CDW)

The deductible of the comprehensive insurance owed in accordance with the rental car agreement is assumed. This also applies to vehicles from car sharing providers.

Cash protection

If you withdraw cash from your account at an ATM during your trip and it is stolen, while being carried by you as well as during a burglary at your accommodation, we will reimburse you for the stolen money, up to the maximum benefit listed for «Cash protection» cover in your Cover summary.

Important information

- Valid worldwide for a journey lasting up to 120 days.
- The «breakdown and accident assistance» benefit applies in Switzerland and Europe.
- The sums insured under the insurance benefits apply per case or per event.
- In the event of theft for the insurance benefit «baggage», a deductible of CHF 200.– shall apply per case.
- For the «Emergency medical assistance» coverage, there is a maximum benefit of CHF 5'000.– for the transport to bedside and a maximum benefit of CHF 10'000.– (Basic), CHF 20'000.– (Plus), CHF 30'000.– (Complete) for search and rescue.
- Also available to people resident abroad if the trip is booked in Switzerland.
- The General terms and conditions of insurance (GTC) apply.
